# NLP MASTERCLASS LTD Terms & Conditions

**Generally:** These terms relate to the courses, services and products provided for by NLP Masterclass Ltd and its other associated trading names including but not restricted to International College of Clinical Hypnotherapy or ICCH.

## 1. Prescribed policy documentation

## a. Equal Opportunities

NLP MasterCLASS is an equal opportunities organisation, offering nondiscriminatory support to ex-students, current students and staff members.

#### b. Confidentiality

Records of personal details are kept confidential, unless we are required by law to divulge them.

#### c. GDPR and Data

Records of personal details are kept in accordance with GDPR and data protection and the company will correspond on occasions related to events and other products and services offered. Participants may opt out of such correspondence.

## 2. Booking conditions.

- a. Booking can be made online via the website using a variety of payment platforms or paid direct to bank by request.
- b. All correspondence related to the event will be made to the e-mail address used at the time of booking.

# 3. Payment

- a. Full pre-payment of courses is required before attendance will be allowed.
- b. On occasions part or staged payments may be offered, payment terms will be clearly displayed, and direct debit, standing order or card staged payments must be made on the dates agreed.
- c. In the event of failed or declined payments, NLP MasterCLASS reserve the right to claim the full balance due and participants agree to cover any costs related to recovery.
- d. If a student fails to pay the balance due as determined by the offer, all early bird or promotional discounts will be forfeit and the full standard price will be due.

## 4. Booking confirmation

a. You will be sent a booking confirmation by email on receipt of your payment which will contain details of the location, start times and other relevant details.

### 5. Course attendance

- a. On the first morning as part of your registration process all participants will be required to sign a waiver regarding the recording of the event this applies to live in person as well as online events.
